Limda, Tal. Waghodia-391 760, Dist. Vadodara, Gujarat from the academic session 2014-15 under Section 13A of the IMCC Act, 1970- reg.

Sir,

In continuation to the Department's letter of even No. dated 30.05.2014 wherein a Letter of Intent was issued to the college with respect to the proposal submitted to the Central Government as cited above, I am directed to say that after careful consideration of recommendations of the CCIM in terms of the provisions of the IMCC Act, 1970 and relevant regulations made thereunder and approved norms for academic session 2014-15, which were circulated vide Department's letter No.R.11011/10/2013-EP (IM-1) dated 17.06.2014 to all the ASU Colleges, Universities and State Governments and also available on Department's website <indianmedicine.nic.in>; permission of the Central Government is hereby granted to the **Managing Trustee, Parul Institute of Ayurved, P.O. Limda, Tal. Waghodia-391760, Dist. Vadodara, Gujarat for starting new Post Graduate Course of Study in 05 subjects namely (i) Kaumarbhritya, (ii) Shalya Tantra-Kshar Karma evam Anushashtra Karma (iii) Prasuti Tantra evum Stri Roga, (iv) Kayachikitsa and (v) Dravyaguna with 6 seats in each subject** from the academic session 2014-15 under section 13A of the IMCC Act, 1970. Therefore, the college may take admissions for the academic session 2014-15 in the aforesaid new PG courses.

2. This permission to **start new Post Graduate Course in 05 subjects namely (i) Kaumarbhritya, (ii) Shalya Tantra-Kshar Karma evam Anushashtra Karma (iii) Prasuti Tantra evum Stri Roga, (iv) Kayachikitsa and (v) Dravyaguna with 6 seats in each subject** for the first admitted batch of 2014-15 session, will be valid till such time as the first batch of students admitted against these courses appear for the first final examination of the said courses and at that time, the College authorities may take up the matter for recognition of the qualifications under Section 14(2) of the IMCC Act, 1970.
