Sir.

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act, 2020 and its relevant regulations.

- 2. As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 proforma were examined by the Medical Assessment and Rating Board.
- 3. MARBH has conducted a Physical Inspection on 23/08/2022. As per the report and further observations of Board, Virtual hearing under natural justice before decision, was conducted on 18/10/2022. On careful consideration of the report, the Medical Assessment and Rating Board has arrived at the following conclusion: -

Since 04 wards have no names Deficiency persists	
iv.	No nurse is available in 43 bedded hospital	College have provided a list of 8 nursing staff with duty roster for the month of August 2022, in which against the name of Miss Sangita ben Apanchal 'no off' is marked for the whole month. Document submitted is not supporting functional duty roster. Deficiency persists.	Deficiency persists
V.	Functionality of OPD & IPD records are doubtful and thus hospital is not properly functional. Hence not fulfill the norms of as per HCC (MSR) of Homoeopathic College and Hospital), 2013 for 100 seats.	As per the online inspection of the Female ward, 05 patients were admitted. As per staff list narrated by the Principal there are 2 cleaning staff for hospital. However, in the staff list there is only one cleaning staff deputed in the hospital. It seems very less man power for the sanitation service of the working hospital having IPD OPD, OT etc. Needs further evidence to substantiate working of hospital	Deficiency persists
vi.	CPF, ESI -Not submitted.	As regards to CPF College have submitted Composite Declaration Form 11 for 85 staff. Further submitted EPF electronic Challan cum return slip from April 2021 to March 2022. Challan showing exempted status. Further, member detail page showing variable No. of members in different months (minimum 9- maximum 12). Therefore, EPF benefit is given to very less number of employees. - 4. After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC(MSR) Regulations, 2013, Medical Assessment and Rating Board is granted conditional permission to Ahmedabad Homoeopathic Medical College, At & PO. Ghuma-Bopal Road, Ghuma, Ahmedabad-380058, Gujarat for student intake of 100 UG (BHMS) seats and for 18 seats in PG [MD (Hom)] with (06) Organon of Medicine, (06) Materia Medica and (06) Repertory academic year 2022-23. The Principal is directed to fulfill the deficiencies within three months and an undertaking from the controlling authority of the college may be submitted in this regard to the Medical Assessment Board within a period of one week.
- 5. All admissions in Under Graduate (BHMS) course and PG course in MD (Hom) shall be through 'National Eligibility Entrance Test (NEET)'/AIAPGET only. It is further informed that, minimum 15% seats of permitted intake capacity of BHMS course shall be treated as All India Quota. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided by NCH will be imposed on the college.
- 6. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State/ UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State / UT. 100% Under Graduate of the permitted intake capacity shall be treated as all India quota for Deemed University as they are All India in nature. The Counseling of seats under All India Quota shall be conducted by Central Government.
- 7. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.
