

Application for Letter of permission for functioning of Ahmedabad Homoeopathic Medical Sub: College, Bopal Ghuma Road, Ghuma, District -Vadodara, Ahmedabad-380058, Gujarat for Admission in BHMS Under Graduate Course with Intake Capacity of 100 Seats for BHMS and for Post Graduate Course (MD) with intake capacity of total 18 seats in 03 subjects namely 06 seats Organon of Medicine, 06 seats in Repertory and 06 in seats Homocopathic Materia Medica for academic year 2024- 25- regarding.

Ahmedabad Homoeopathic Medical College, Bopal Ghuma Road, Ghuma, District Vadodara, Ahmedabad-380058, Gujarat for Admission in BHMS Undergraduate Course for the with Intake Capacity of 100 Seats for BHMS and for Post Graduate Course (MD) with intake capacity of total 18 seats in 03 subjects namely 06 seats Organon of Medicine, 06 seats in Repertory and 06 in seats Homoeopathic Materia Medica for the academic year 24-25. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under NCH Act 2020, as per section 29 and subsection (3) of the Act.

As per the observations made by MARB, the following information are provided for immediate rectification of the shortfalls. College shall fulfil all functional requirements as per the Minimum Standard Requirements as mentioned below:-

Teaching faculty: -

- In PG department of Repertory and Organon of Medicine one reader faculty is needed to be appointed for 06 seats. The vacancy may be fulfilled as per requirements of MSR 2013 within 30
- 09 Consultants of Modern Medicine and 12 guest faculty as per MSR requirements and the copy of the attendance register and Acquittance roll for the last 3 months shall be submitted for verification.

Hospital facilities: -

- a) IPD/OPD Case sheets shall be maintained with demographic details complete case history, analysis, evaluation and repertorisation and made available in the Medical Record Room for academic purposes of students and for follow-up attendance of the patients.
- b) Bed Occupancy in % (P X 100 / 275 X B)- 27.88 % is less than the requirement of 33% as per MSR 2013.
- c) OPD /IPD Case records are not available. Blank case format with OPD/IPD register have been submitted by the college. Case records shall be submitted against the direction issued from MARB. IPD and OPD case records (copy of one OP and one IP case of 1st and last day of the last six months) shall be submitted for verification.

- d) USG/ECG register not submitted.
- Financial details: Form -16 of hospital staff are not from traces portal.

Considering the above observations, and facilities available, MARB has decided to issue Permission to Ahmedabad Homoeopathic Medical College, Bopal Ghuma Road, Ghuma, District -Vadodara, Ahmedabad-380058, Gujarat for Admission in BHMS Under Graduate Course with Intake Capacity of 100 Seats for BHMS and for Post Graduate Course (MD) with intake capacity of total 18 seats in 03 subjects namely 06 seats Organon of Medicine, 06 seats in Repertory and 06 in seats Homoeopathic Materia Medica for academic year 2024- 25.

All deficiencies noticed shall be rectified within a period of one month and the compliance report shall be submitted for verification.

All admissions shall be made by NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by Medical Assessment and Rating

Permission to the college can be withdrawn or denied in the subsequent year if the college is found deficient in compliance with MSR 2013, anytime during the academic year.
