As per provision of NCH Act, 2020 Medical Assessment and Rating Board for Homoeopathy (MARBH) has been constituted with the mandate to grant permission for student intake to the existing and new medical institution of Homoeopathy.

- As per provision of NCH Act, 2020 Medical Assessment and Rating Board for Homoeopathy (MARBH) has been constituted with the mandate to grant permission for student intake to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform that Part-1 Performa and all the relevant documents submitted by your college were examined as per the existing regulations.
- 3. On scrutiny and careful consideration of your documents and further observations of the Board, the following shortfalls to be addressed for granting permission for student intake in UG (BHMS) course and Post Graduate Course MD(Hom.) for the academic year 2022-23:
- A. Hospital Staff:
- a. 05 House Physician are available against the requirement of 08.
- b. 07 Ward boys are available against the requirement of 09.
- Staff for OPD registration and Hospital catering are not available
- B. Website: College website (https://institutes.paruluniversity.ac.in/faculty/faculty) is not functional.
- That the applicant has set up the Homoeopathic Medical College and teaching Hospital with the component of staff, infrastructure, equipment and instruments and other facilities where as the College has to take urgent and time bound steps to fulfill the above requirements for conducting Under Graduate course in Homoeopathy.
- Assessment and Rating Board for continuing student intake is issued to Jawaharlal Nehru Homoeopathic Medical College, Parul University Campus, Post Limda Vadodara, Taluka Waghodia, Gujarat with student intake of 100 seats in UG (BHMS) course and 24 seats in Post Graduate Course [MD(Hom.)] in 04 Departments namely Organon of Medicine (06) seats, Materia Medica (06) seats, Repertory (06) seats all deficiencies within a period of 01 month and an undertaking shall be submitted in this regard from the Controlling Authority of the College.

- 6. As per section no. 43 of the NCH Act 2020, vide letter no. Y-11011/4/2022-EP-III dated 14/10/2022. Central Govt. has taken a policy decision that all admission shall be through NEET only with qualifying marks 50 percentile. All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET)' only. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided will be imposed only.
- 7. All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET)' and all admissions in Post Graduate course shall be through 'All India Ayush Post Graduate Entrance Test (AIAPGET)' only. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided will be imposed.
- 8. The counselling for seats under All India quota shall be conducted by respective counselling Authority of State/ UT Government as designated by the Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counselling Authority of that State / UT. 100% Under Graduate & Post Graduate seats of the permitted intake capacity shall be treated as all India quota for Deemed University as they are All India in nature. The Counselling of seats under All India Quota shall be conducted by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.

The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.
