Jawaharlal Nehru Homoeopathic Medical College, Gujarat-391760 is functional since 2002 and has submitted an application for permission for sanction of 100 seats in UG (BHMS) course and 24 seats in Post Graduate Course [MD(Hom.)] in 04 Departments namely Organon of Medicine with 06 seats, Materia Medica with 06 seats, Repertory with 06 seats and Practice of medicine with 06 seats for the academic year 2023-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Standard Requirement to be fulfilled as per the prevailing regulations under NCH Act 2020. As per the observations made by MARBH, following shortfalls are noticed for immediate rectification:

Teaching Faculty: For PG course, Professor in the Dept. of Organon, Associate Professor in the dept. of Materia Medica, Associate Professor in the dept. of Repertory are not available. These vacancies need to be filled up and details shall be submitted to MARB within 15 days.

College is required to follow standard guidelines in the functioning as under:

- Case records should be well maintained with case analysis, evaluation and repertorization and made available in the Medical Record Room for academic purpose of students and follow up attendance of patients.
- Case sheets should have complete demographic details and contact details of patients.
- Diagnosis should be written in ICD 11 criteria

Therefore, Medical Assessment and Rating Board for Homoeopathy has decided to issue **conditional permission to Jawaharlal Nehru Homoeopathic Medical College, Parul University Campus, Post Limda Vadodara, Taluka Waghodia, Gujarat-391760 for conducting BHMS**




course with student intake of 100 seats in UG (BHMS) course and 24 seats in Post Graduate Course [MD(Hom.)] in 04 Departments namely Organon of Medicine with 06 seats, Materia Medica with 06 seats, Repertory with 06 seats, Practice of medicine with 06 seats for the academic year 2023-24 – reg.

The shortfalls observed in your College shall be rectified within a period of 15 days or before counselling initiates whichever is earlier and compliance report shall be submitted to the MARB, failing which the conditional permission issued will be withdrawn without further notice.

All admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that 100% of seats of the permitted intake capacity of UG (BHMS course) and PG {MD(Hom.)} Scourse shall be treated as All India Quota. Counselling for seats under All India Quota shall be conducted by the Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt. for All India Quota or the student admitted thereunder.


The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by Medical Assessment and Rating Board.
