Sub.: Application of President, Parul University, Distt., Vadodara to start a new Homoeopathic Medical college in the name and style “Parul Institute of Homoeopathy and Research”, Distt., Vadodara, Gujarat with 100 seats in BHMS course from the academic session 2017-18 under Section 12A of the HCC Act, 1973 - regarding.

Sir,

I am directed to refer your application dated 26.04.2016 (received on 29.04.2016) on the subject cited above and to say that the proposal was sent to the Central Council of Homoeopathy on 26.05.2016 for carrying out an inspection of the proposed college and furnishing recommendations for the academic session 2017-18.

2. CCH had inspected the said college on 21.09.2016 and submitted the inspection report and recommendation vide F.No. 15-5/2016/CCH -32202 dated 14.02.2017 conveying the decision of the Executive Committee held on 09.02.2017 as under :-

““The Executive committee in its meeting held on 09.02.2017 consider the matter and decided to recommend for issue of LoI for admission of 100 students in parul Institute of homoeopathy and Research, Distt., Vadodara in BHMS (Degree Course) from 2017-18 session”.

3. The Central Government while examining the inspection report of CCH for proposed "Parul Institute of Homoeopathy and Research" in terms of the provisions under the HCC Act, 1973, relevant regulations made there under and Ministry's Policy, observed the following shortcomings for issuing LoI:-

- (i) The Proposed new Homoeopathic Medical college "Parul Institute of Homoeopathy and Research" of Parul University is situated in the same address (campus) where another Homoeopathic college namely "Jawaharlal Nehru Homoeopathic Medical College" is functioning by the same Parul University. Hence, requisite land, infrastructure and staff of both the existing (Jawaharlal Nehru Homoeopathic Medical College) and proposed homoeopathic college and hospitals may be clarified to ensure that separated requirement in respect of infrastructure staff, space, equipment are available.

4. The applicant college was given an opportunity of hearing on 21.03.2017 to present its case with respect to the above mentioned short coming.

5. After careful examination of the application and taking into consideration of the recommendations of the Central Council of Homoeopathy, report of the hearing committee and Policy of the Ministry, the Letter of Intent (LoI) to Parul University, Distt., Vadodara is hereby granted to start a new Homoeopathic Medical college in the name and style "Parul Institute of Homoeopathy and Research", Distt., Vadodara, Gujarat with 100 seats in BHMS course from the academic session 2017-18 under Section 12A of the HCC Act, 1973. Further, the college shall fulfil the following conditions before the inspection by CCH for consideration of permission (LoP) for the academic year 2017-18 :-

- (i) That, the applicant shall fulfill all the relevant provisions under the HCC Act, 1973.
- (ii) that, the College shall fulfil all the Minimum Standards Requirements of infrastructure and teaching & training facilities as specified in "Homeopathy Central Council (Minimum Standards Requirement of Homeopathic Colleges and attached Hospitals) Regulations 2013" before the inspection by CCH, regarding the matter for consideration of permission for academic year 2017-18.
- (iii) that, the college shall have a genuinely functional hospital with required average number of patients in OPD and IPD, required bed occupancy rate etc.
- (iv) that, the college shall have required number of instruments/equipment as per HCC (MSR), 2013.
- (v) that, the applicant shall fulfill all the relevant provisions of Regulations namely "Establishment of New Medical College, opening of new Higher course of study or training and increase of admission capacity by a medical college Regulations 2011.
- (vi) that, the college has to submit an undertaking that the college has not already admitted students in any class or standard course or training of the proposed Medical college.
- (vii) that, the College has also to submit the requisite performance bank guarantee of Rs. 1.5 Crore as specified under the section 6 (1) (g) of notified Regulation 2011, failing which the letter of Intent may be withdrawn.



6. In the event, the applicant college fails to comply with or satisfy the conditions of the Letter of Intent, the LoI would automatically lapse and be treated cancelled without further reference to the applicant college.

7. The College administration has to ensure that no student is admitted in the above mentioned courses till the formal permission of the Central Government is granted.


