Sub:- Letter of Permission to start a new Homoeopathic Medical college in the name and style "Parul Institute of Homoeopathy and Research", Distt., Vadodara, Gujarat with 100 seats in BHMS course from the academic session 2017-18 under Section 12A of the HCC Act, 1973- in compliance of order dated 03.11.2017 of Hon'ble High Court of Gujarat at Ahmadabad and Hon'ble Supreme Court of India order dated 14.09.2018- regd.

Sir,

Vide this Ministry's letter No. R.12014/22/2016- EP (H) dated 18.10.2017, wherein permission to start a new Homoeopathic Medical college in the name and style "Parul Institute of Homoeopathy and Research", Distt., Vadodara, Gujarat with 100 seats in BHMS course from the academic session 2017-18 under Section 12A of the HCC Act, 1973 was denied, as the college was not meeting the Minimum Standard Requirement (MSR) Regulations, 2013.

The college has challenged the denial order of this Ministry in High Court of Gujarat at Ahmadabad by filing the letters patent Appeal No. 1797 of 2017 in Special Civil Application No. 17956 of 2017, the Hon'ble High Court vide order dated 03.11.2017 quash the order of this Ministry dated 18.10.2017 and directed AYUSH Ministry to issue the letter of permission for the academic year 2017-18. Ministry of AYUSH approached the Hon'ble Supreme Court of India and filed the Special Leave Petition being SLP(c) Diary No. 28531/2018, which has been dismissed vide order dated 14.09.2018 by the Hon'ble Supreme Court of India.
3. In pursuance of the order of Hon'ble High Court of Gujarat at Ahmadabad dated 03.11.2017 and Hon'ble Supreme Court of India order dated 14.09.2018, the undersigned is directed to convey the approval of Competent Authority to grant permission to start new Homoeopathic Medical college in the name and style "Parul Institute of Homoeopathy and Research", Distt., Vadodara, Gujarat with 100 seats in BHMS course from the academic session 2017-18 under Section 12A of the HCC Act, 1973.
