Parul Institute of Homoeopathy & Research, is functional since 2015 and has applied for permission for sanction of UG (BHMS) course with 100 seats and 24 seats for PG M.D (Hom) in 04 subjects with 06 seats in Homoeopathic Materia Medica, 06 seats in Homoeopathic Philosophy, 06 seats in Repertory and 06 seats in Pharmacy for the academic year 2024-25. The College has submitted the Part 1 information in which the entire functional profile has been narrated. The Medical Assessment and Rating Board has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfalls

1. Miscellaneous

- Form 16 of all the staff is not legible.
- Attendance register & biometric attendance of last academic session of teaching staff - not legible

Considering the above observations and facilities available, MARBH has decided to issue Conditional permission to Parul Institute of Homoeopathy & Research, P.O. Lilmda, Tal. Waghodia, Dist. Vadodara- 391760 for continuing UG (BHMS) course with intake capacity of 100 seats and 24 seats for PG M.D (Hom) in 04 subjects with 06 seats in Homoeopathic Materia Medica, 06 seats in Homoeopathic Philosophy, 06 seats in Repertory and 06 seats in Pharmacy for the academic year 2024-2025 regarding

All deficiencies noticed shall be rectified within a period of one month and compliance report shall be submitted for verification.

All admissions shall be made from NEET/ AIAPGET qualified candidates only. It is further informed that minimum 15% of undergraduate seats and 15% of postgraduate seats of the permitted intake capacity of 100 UG seats and 24 PG seats course shall be treated as All India Ouota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/ AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.

All deficiencies noticed shall be rectified within a period of one month and compliance Report shall be submitted for verification.
