Sir,

Parul Institute of Homoeopathy & Research is functional since 2015 and has applied for permission for sanction of BHMS course with 100 seats and 24 seats for M.D (Hom) in 04 subjects with 06 seats in Homoeopathic Materia Medica, 06 seats in Homoeopathic Philosophy, 06 seats in Repertory and 06 seats in Pharmacy for the academic year 2025-26. The College was inspected on 14.02.2025 & 15.02.2025 in which the entire functional profile has been examined. The Medical Assessment and Rating Board has examined the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls

## 1. Teaching faculty.

- A. In light of the relaxation order issued by MARBH on 16.04.2025 following teacher shall be appointed as early as possible :-
- Associate Professor in department of research methodology and biostatistics.
- B.
- A separate visiting faculty of minimum cadre of Assistant Professor should be engaged for teaching fundamentals of psychology.
  - Details of practicing consultants as visiting faculty of modern medicine or homeopathy are not available.

## 2. Miscellaneous

- Salary of teaching staff and non-teaching staff is not as per MES 2024

Considering the above observations during inspection, MARBH has decided to issue Conditional permission to Parul Institute of Homoeopathy & Research, P.O. Lilmda, Tal. Waghodia, Dist. Vadodara- 391760 for continuing BHMS course with intake capacity of 100 seats and 24 seats for M.D (Hom) in 04 subjects with 06 seats in Homoeopathic Materia Medica, 06 seats in Homoeopathic Philosophy, 06 seats in Repertory and 06 seats in Pharmacy for the academic year 2025-26.




All admissions shall be made from NEET/ AIAPGET qualified candidates only. It is further informed that minimum 15% of undergraduate seats and 15% of postgraduate seats of the permitted intake capacity of 100 UG seats and 24 PG seats course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/ AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.

**All deficiencies mentioned at point 1(B) and point 2 shall be rectified within a period of one month and the compliance report shall be submitted for verification, failing which permission for academic year 2025-26 may be withdrawn.**
