Sub: Application for opening of new PG courses in existing college in 04 subjects i.e Materia Medica, Repertory, Organon and Pharmacy with 06 seats each (Total 24 seats) for Parul Institute of Homoeopathy and Research, At Ishwarpura, P.O. Limda Ta. Waghodia, Vadodara – 391760, Gujarat for A.Y. 2023-24 under Section 29 of NCH Act 2020, reg. -

Sir,

The Medical Assessment and Rating Board has received an application to start new post graduate course in M.D.(Hom.) with 24 seats in 04 subjects namely, Materia Medica, Repertory, Organon and Pharmacy with 06 seats each for academic session 2023-2024 as per the prevailing regulations under NCH Act, 2020.

2. MARBH has conducted the Inspection of college on 05/04/2023, followed by hearing on 30/05/2023. Accordingly, it is to inform you that all the relevant documents submitted by your college, inspection reports submitted by inspectors and supportive annexure, were examined by the Medical Assessment and Rating Board and following observations had been noticed.

- The College shall submit separate UG and PG faculty list with their qualification and experience certificates. Appointment and joining letter of PG faculty shall be submitted.
- Considering the necessity of teachers as per regulations in UG and PG departments, teaching faculties are not available apart from the minimum requirement in UG departments. The student intake is done as per available qualified Guides in the PG departments.

3. After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and NCH Act 2020 and its relevant regulations **permission of the Medical Assessment and Rating Board is issued to Parul Institute of Homoeopathy and Research to start new post graduate course in M.D.(Hom.) with 15 seats in 04 subjects namely, Materia Medica (03 seats), Repertory (04 seats), Organon (04 seats) and Pharmacy (04 seats) for A.Y. 2023-24.** The Principal is directed to fulfill the deficiencies within 30 days and an affidavit in this regard may be submitted to the Medical Assessment Board within a period of one week.

4. All admissions in Post graduate course shall be through AIAPGET only. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted thereunder.


5. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions

carried out other than AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board as per Rules. The College has to comply with the full requirements of NCH Act 2020 and its relevant regulations for conducting the course.

6. The Board shall verify the compliance well in time and may conduct Online/Physical inspection for verification of compliance as per the NCH Act 2020 and will consider admissions for the academic year 2024-25.

7. As per section 24 (3) of NCH Act 2020, The College aggrieved by any decision of the Autonomous Board may prefer an appeal to the Commission against such decision within 30 days of the communication of such decision
