Sub: Application for Letter of permission for functioning of Rajkot Homoeopathic Medical College, Jainath Petrol Pump, Gondal Road, Rajkot-360002, Gujarat for Admission in BHMS Course with Intake Capacity of 100 Seats for undergraduate course and for Postgraduate with intake capacity of total 24 seats in 04 subjects namely Organon of Medicine, Repertory, Homoeopathic Materia Medica and Practice of Medicine with 06 seats for the Session 2024-25 – regarding.

Rajkot Homoeopathic Medical College, Jainath Petrol Pump, Gondal Road, Rajkot-360002, Gujarat for Admission in BHMS Course with Intake Capacity of 100 Seats for undergraduate course and for Postgraduate with intake capacity of total 24 seats in 04 subjects namely Organon of Medicine, Repertory, Homoeopathic Materia Medica and Practice of Medicine with 06 seats for the Session 2024-25. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under NCH Act 2020, as per section 29 and subsection (3) of the Act.

As per the observations made by MARB, following information are provided for immediate rectification of the shortfalls. College shall fulfil all functional requirements as per the Minimum Standard Requirements as mentioned below:-

• **Teaching faculty: -**

- Out of 38 fulltime faculty for UG and PG. There is no separate PG faculty list provided.
- In PG Department of Materia Medica- No extra Professor Faculty is available other than UG requirement.
- In PG department of Organon of Medicine – No extra Reader faculty is available other than UG requirement.
- 06 consultants are mentioned in the list against requirement of 09 Consultants of Modern Medicine. This shall be provided with name in attendance and Acquittance role.

• **Hospital facilities: -**

- IPD/OPD Case sheets shall be maintained with complete case history analysis and evaluation and repertorisation and made available in the Medical Record Room for academic purposes of students and for follow-up attendance of the patients.

- **Miscellaneous: -**AEBAS is not enabled in the college. Same shall be enabled within a period

of 30 days.

- **Financial details:** Form -16 of staff are not from traces portal.

Considering the above observations, and facilities available, MARB has decided to issue **Conditional Permission to Rajkot Homoeopathic Medical College, Jainath Petrol Pump, Gondal Road, Rajkot-360002, Gujarat for Admission in BHMS Course with Intake Capacity of 100 Seats for undergraduate course and for Postgraduate with intake capacity of total 24 seats in 04 subjects namely Organon of Medicine, Repertory, Homoeopathic Materia Medica and Practice of Medicine with 06 seats for the Session 2024-25.**

All the shortfalls observed in your College shall be rectified within a period of 30 days or before counselling initiates, whichever earlier and compliance report shall be submitted to the MARB, failing which the conditional permission issued will be cancelled without further notice.

All admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by Medical Assessment and Rating Board.
