Application for Letter of permission for functioning of Rajkot Homoeopathic Medical Sub: College, Jainath Petrol Pump, Gondal Road, Rajkot - 360002, Gujarat for admission with intake capacity of 100 seats for conducting Undergraduate (BHMS) course and 24 seats for post graduate course [MD (Hom.)] in 04 departments namely, Organon, Materia Medica and Repertory and Practice of Medicine with 06 seats each for the academic year 2023-24-reg.

Sir.

Rajkot Homoeopathic Medical College, Rajkot, Gujarat has submitted an application for permission for sanction of 100 seats in BHMS course and 24 seats in PG [MD(Hom.)] for the academic year 2023-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Standard requirements s to be fulfilled as per the prevailing regulations under NCH Act 2020. As per the observations made by MARBH, following lacunae are to be rectified with immediate effect. College shall fulfil all functional requirements as per the Minimum Standard requirements.

- a) Form-16 from TRACES portal not provided.
- b) Biometric attendance not provided.
- c) Case records should be well maintained in respect of case analysis, evaluation and repertorization and made available in Medical Records Room for academic purpose of students and follow up attendance of patients. Case sheets should have complete demographic details and contact details of patients.
- d) Diagnosis should be written in ICD 11 criteria.

Considering the above observations, and facilities available, MARB has decided to issue conditional permission to Rajkot Homoeopathic Medical College, Jainath Petrol Pump, Gondal Road, Rajkot - 360002, Gujarat for admission with intake capacity of 100 seats for conducting Undergraduate (BHMS) course and 24 seats for post graduate course [MD (Hom.)] in 04 departments namely, Organon, Materia Medica and Repertory and Practice of Medicine with 06 seats each for the academic year 2023-24. All the shortfalls observed in your College shall be rectified within a period of 30 days or before counseling initiates whichever earlier

and compliance report shall be submitted to the MARB, failing which the conditional permission issued will be withdrawn without further notice.

All admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by Medical Assessment and Rating Board.
