Sub: Application for Letter of permission for functioning of Rajkot Homoeopathic Medical College, Behind Jaynath Complex, Near Makkam Chowk, Gondal Road, Rajkot – 360002 Gujarat for Admission in BHMS Under Graduate Course with Intake Capacity of 100 seats for BHMS and for Post Graduate Course (MD) with intake capacity of total 24 seats in 04 subjects namely Organon of Medicine, Practice of Medicine, Repertory and Homoeopathic Materia Medica with 06 seats each for academic year 2025-26 – reg.

Sir,

Rajkot Homoeopathic Medical College, Gujarat has submitted an application for permission for sanction of 100 seats in BHMS course and for Post Graduate Course (MD) with intake capacity of total 24 seats in 04 subjects namely Organon of Medicine, Practice of Medicine, Repertory and Homoeopathic Materia Medica with 06 seats each for the academic year 2025-26. The College has submitted the Part 1 information in which the entire functional profile has been narrated. The Medical Assessment and Rating Board (MARBH) has conducted Inspection on 14.02.2025 and 15.02.2025, followed by hearing on 19.05.2025. MARBH has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards 2024 as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls.

- 1. Teaching Staff: Deficiencies are observed in documents of following 01 teaching staff:
 - a) Department of Organon of Medicine: Dr. Nirav Ganatra (Assistant Professor): Post graduation degree in Homoeopathy not provided.

As evident from the above statement, a total number of one teacher is deficient against the requirement of 40+1 for 100 seats UG college (As specified in MES,2024). Pursuant to F.No. :3-2/MARBH/NCH/2025-26/162-169 dtd. 16/04/2025 issued by MARBH, a college can avail 10% relaxation against the required number of teachers for Academic Year 2025-26 only. After allowing relaxation of 10%, college has no deficiency in teaching staff. However, such relaxed number of teachers may be appointed at the earliest for smooth conduct of course.

 Considering the above observations during inspection, MARBH has decided to issue permission to Rajkot Homoeopathic Medical College, Behind Jaynath Complex, Near Makkam Chowk, Gondal Road, Rajkot – 360002 Gujarat for Admission in BHMS Under Graduate Course with Intake Capacity of 100 seats for BHMS and for Post Graduate Course (MD) with intake capacity of total 24 seats in 04 subjects namely Organon of Medicine, Practice of Medicine, Repertory and Homoeopathic Materia Medica with 06 seats each for the academic year 2025-26.

- 3. All admissions shall be made from NEET/ AIAPGET qualified candidates only. It is further informed that minimum 15% of undergraduate seats and 15% of postgraduate seats of the permitted intake capacity of 100 UG seats and 24PG seats course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.
- **4.** The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.
