 - (i) the college shall provide an undertaking regarding the selection of students for PG is made strictly on the basis of academic merit as prescribed by CCIM.
 - (ii) the college shall appoint 4 Clinical Registrar in the College Hospital.
 - (iii) the area of Demonstration Room of Herbal Gardern (25 sq.mt.) should be available as per MSR.
 - (iv) the college gets the permission of the Central Government to undertake admission at existing UG/PG course/s for the academic year 2015-16;
 - (v) the applicant shall fulfill all the requirements of infrastructure for teaching and training facilities as specified in Regulations namely the "Indian Medicine Central Council (Minimum Standard Requirements of Ayurveda Colleges and attached Hospitals) Regulations, 2012" read with amendment Regulations of 2013;
 - (vi) the applicant shall fulfill all the requirements of the "Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) (Amendment) Regulations, 2012" read with amendment Regulations of 2013;
 - (vii) the applicant shall fulfill all the requirements under the Indian Medicine Central Council (Post-graduate Ayurveda Education) Regulation, 2012;
 - (viii) the applicant shall fulfill all the relevant provisions of Regulations namely the "Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2003" read with amendment Regulations of 2013 and
