
2. Approval of the Provost

Sub: Modifications to the Regulations governing the degree programmes offered by the University

Ref: Notification of even number dated 18-12-2015


In the earlier notification concerning the subject mentioned above, it is felt necessary to make certain modifications regarding some provisions mentioned therein. These shall be called modifications to the regulations notified on 18-12-2015 and notwithstanding anything contained in the original notification, these regulations shall have a overriding effect on the regulations for each of the degree programmes.

1. In case, a student is desirous of entering Parul University (PU) to a degree programme by transfer after completing a part of the same degree programme in another university, he/she may do so provided the student shall be given the benefit of transfer of credits as recommended by an Equivalence Committee.
Provided further that such transfer would be granted if only the student completes at least 50% of the prescribed course work in PU.
2. A student to be eligible to appear in the End Semester Examination shall have to score a minimum of 40% or 50% as the case may be in the Continuous Evaluation and Mid-Term Examination taken together.
3. If a student desires to obtain a copy of his evaluated answer papers in any or all the subjects for which End Semester Examination has been held, such a student may be provided a photocopy of his/her evaluated answer paper on payment of a fee of 250/-.
4. If a student is aggrieved by the marks obtained in the end semester examination in any subject, such student may apply for re-evaluation of the answer paper by paying the prescribed fees. The answer paper then will be evaluated by a second examiner. If the difference in marks allotted between the first and second examiner is a minimum of 10% of the passing head (i.e. out of 60) then the answer paper shall be evaluated by the third examiner. If the marks allotted between the first examiner and the third examiner

is also a minimum of 10% of the marks in the passing head, then the student shall be awarded the average of the marks awarded by the second and third examiners.

This notification comes into effect immediately.
