Constitution of the Board of Research Studies

The Dean, faculty of Ayurved shall appoint teaching faculties of Parul Institute of Ayurveda and Parul Institute of Ayurveda and Research who have excelled in the field of research as Members of the said Board.

Roles and responsibilities of Board of Research Studies

- It shall monitor and scrutinise research activities conducted under the aegis of Parul Institute of Ayurved and Parul Institute of Ayurveda and Research.
- It shall report to the Dean, Faculty of Ayurved about status and quality of research projects conducted under the aegis of Parul Institute of Ayurved and Parul Institute of Ayurveda and Research.
- In case of any discrepancy, lack of data/ proofs related to research activities, it can suggest necessary actions against such incidence(s) to the Dean, faculty of Ayurved.
- It shall take necessary steps to enhance knowledge and create awareness about research among post graduate, doctoral research scholars and faculties.
