
Sanction Order:

An application with proposal for setting up of **Development of a state of the art MICRO-NANO Research & Development Centre** under Scheme-1 of Scheme for Assistance for Research & Development Activities -2020 vide resolution read at (1) above was placed before the State Level Empowered Committee in its 2ND meeting held on Dt.22.06.2023.

In exercise of the powers vested under Government Resolution referred at (1) above, sanction is hereby accorded for the project proposal referred at (2) above for financial assistance under the scheme and sanctioned assistance of **Rs. 149.55 Lakh**, subject to the following conditions:

- 1) The assistance will have to be utilized for the purpose for which it is sanctioned and reimbursed.
- 2) The project would be completed within the operative period of the scheme.
- 3) After completion of the project, the applicant shall apply to Office of Industries Commissioner for claim of assistance approved. On receipt of claim application with all necessary details along with the supporting documents, The Office of the Industries Commissioner will scrutinize the claim application and a physical inspection will be carried out to decide the actual amount of assistance eligible for Reimbursement.
- 4) On receipt of Claim inspection report and the recommendations by the inspecting team, the assistance will be reimbursed by the Office of the Industries Commissioner.
- 5) The assistance shall be exclusively utilized for the specified purpose for which it has been sanctioned. It shall not be utilized for any means other than the creation of approved facilities.
- 6) The applicant shall maintain separate books of accounts for the approved project.
- 7) The applicant shall provide Statement and Grant Utilization Certificate in the prescribed format to the Office of Industries Commissioner.
- 8) The expenditure incurred during operative period for creation of eligible assets as per the provisions of the scheme will be eligible for assistance.

- 9) The applicant shall remain in operation for at least 05 Years from sanction under the scheme.
- 10) The applicant shall have to observe pollution control measures as prescribed by GPCB or other competent authority as applicable to them.
- 11) If the applicant has taken Term loan and becomes defaulter, the applicant shall inform the Office of Industries Commissioner within 15 days.
- 12) The applicant shall have to present the progress report of the project as and when asked by the Office of Industries Commissioner.
- 13) The applicant shall have to present information about any Achievements, Progress and Milestones achieved by proposed R&D facility for the purpose of the Impact analysis of the Policy annually.
- 14) The applicant shall mention on their official website related to the above sanctioned project, that they are sanctioned by the Government of Gujarat under the scheme referred at (1) above.
- 15) In case of any change in legal structure of applicant carrying out above project, the applicant shall inform the Office of Industries Commissioner with supporting documents within 15 days from the date of such change. It will be required till submission of Grant Utilization Certificate of approved assistance for the project to the Office of Industries Commissioner.
- 16) The applicant shall follow all the prescribed conditions jointly and cumulatively as mentioned in GR, Operating Guidelines and Sanction Letter and shall display basic integrity and professionalism. Any breach of which may contribute to discontinuation of reimbursement of assistance and debarment from scheme.
- 17) The facility incentivised by the State Government shall issue the directives to give preferences to the Women Entrepreneurs, Start-ups and MSME Enterprises of the state as the beneficiaries of the facility.
- 18) The applicant shall have to submit a letter of acceptance of this sanction to this office within **15 Days**.
