Sub: - Constitution of Anti-Ragging Committee at University Level

Ref: (i) UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 and subsequent amendments made to the same from time to time

(ii) Orders of the President

PREAMBLE:

The University Grants Commission, New Delhi published regulations to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student or indulging in rowdy or indisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student in all higher education institutions in the country.

In all the constituent institutes of the university, anti-ragging committees have been constituted.

The university hereby constitutes Anti-Ragging Committee at the university level in order to ensure a ragging-free campus.

Functions of the Anti-Ragging Committee at the University Level

- To ensure that wide publicity is given to UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions and that ragging is totally prohibited in the university and anyone found guilty of ragging and/ or abetting ragging, whether actively or passively, or being part of conspiracy to promote ragging, shall be liable to be punished in accordance with the UGC stipulations
- To ensure that anti-ragging committees constituted at institutional level perform the duties effectively in accordance with UGC Stipulations on Curbing the Menace of Ragging in Higher Educational Institutions
- On receipt of the recommendation of the Anti-Ragging Committee or on receipt of any information concerning any reported incident of ragging, the Anti-Ragging Committee at university level shall conduct and complete inquiry within a period of seven days of the reported incident of ragging
- The Anti-Ragging Committee of the University shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging on the recommendations of the Anti-Ragging Committees constituted at institutional level as suggested under UGC stipulations on Curbing the Menace of Ragging in Higher Educational Institutions

Sub: Anti-Ragging Affidavits

The HOIs may kindly recall that in the meeting held under the Chairmanship of the Provost on 16.09.2016, the Heads were requested to initiate the process of obtaining signed affidavits from the students admitted to PU during 2016-17 regarding their commitment to Anti-Ragging in the University. The Dean, Faculty of Law, was also requested to arrange for a Notary to endorse the affidavits.

In the meantime, the Dean, Faculty of Engineering & Technology, Dr. Shital Shah has suggested that UGC has online system of submitting the affidavits by the students and is available on the portal "www.ANTIRAGGING.in." It is convenient for all the students to fill this form online after which the UGC will send the affidavit formats in the names of the student and his/her parents. These will be signed by the students/parents and shall be filed in the respective institutes for records. It is now decided that logging on to UGC website will be adopted for obtaining the affidavits.

The process of filing is simple if followed in the way directed:

Step 1: Log on to www.ANTIRAGGING.in or www.AMANMOVEMENT.org. Click on the button called – On line affidavits.

Step 2: Fill in the information as desired and submit the form.

Step 3: On successful completion, you will receive affidavits, both for students and parents, through e-mail.

In case, the student does not have an e-mail address, he/she will have to create one before he/she logs in. If his/her parents do not have an e-mail/mobile/ landline phone number, he/she may give those of his/her friends or relatives.

The HOIs may call the concerned students in batches of 10 or 20 each depending upon the facility available and ensure that each student files the Online Application Form. This process may be completed by October 5, 2016 and the compliance report may be filed with the undersigned.

In continuation of the Circular cited at ref., it is brought to the information of HOIs that as per the stipulations of the UGC, the Anti-Ragging Committee (ARC) for each education institution should necessarily include one person from civil and police administration/ NGOs involved in Youth Activities. In the ARCs constituted by the HOIs during the last year, nominations of such persons is not made thus, making it incomplete. The HOIs are requested to nominate one such person on the respective ARCs immediately and renotify the constitution of ARC latest by 27.7.2016. Further, the HOIs of the newly started institutions may constitute the ARCs immediately with the existing staff members and notify the same under intimation to the undersigned.

The HOIs were requested to form Anti-Ragging Squads in their institutions. They are once again requested to comply with the same and report progress latest by July 27, 2016.

CIRCULAR

Sub: Prevention of Ragging in Institutions

The process of admission for the academic year 2016-17 has begun. In some degree programmes, the students who are admitted to first year have already reported to the respective institutions attending the bridge courses/ orientation programmes. The UGC has directed all the universities to strictly implement anti-ragging measures in universities and colleges. It is also the responsibility of the institutions in the university to ensure safety of the newcomers and to protect them from any incidence which may harm either their physical or mental faculties. The Heads of Institutions may implement anti-ragging measures strictly in their institutions. Some of the indicative measures which may be followed are as under:

- (a) Display visible information on the effects of ragging in prominent places in the institution
- (b) Display the composition of Anti-Ragging Committee with the telephone numbers of all the members prominently so that they are visible to the newly admitted students
- (c) Form Anti-Ragging Squads in the institution comprising groups of teachers. These Squads may be asked to take periodical rounds of the classrooms, canteen and hostel so as to assure the new admittees that they are protected against any possible ragging activities.

- (d) The Head of the Institution with the help of senior teachers may go to the classrooms of senior classes and talk to the senior students about the fall out of ragging. They may also be advised to treat the freshers in a friendly manner and instill confidence in the newcomers.
- (e) The HOIs may also make efforts to attach three or four freshers to each willing senior students so that the freshers will feel safe under the watchful guidance of the seniors.
- (f) The Rectors are advised to take regular rounds of the hostels both in the mess and in the rooms so as to avoid any unpleasant happenings in the hostels.

The above measures are only indicative and the HOIs are requested to implement any other measure which they find is suited to avoid ragging in the premises.

The above measures may be strictly implemented and compliance be reported to the university periodically.

Anti Ragging Campaign

Notification to Students

Prohibition of Ragging

1. Ragging means display of disorderly conduct, doing of any act, which cause or is likely to cause physical or psychological harm for raised apprehension or fear or shame for embarrassment to student in and educational institute and include;
 - I) Teasing, abusing, threatening for playing practical jokes on or causing hurt to student or
 - II) Asking a student to do any act or perform something with the student will not in the ordinary course, willingly do.
2. The student for his or her parents or guardian or the teachers of an educational institute can complaint to the head of the institute in writing.
3. Immediate disciplinary action will be taken against students involved in ragging.
4. Any student who is proved to be guilty in ragging will face inquiry in the police station within the jurisdiction of the institute.
5. Whoever directly or indirectly committee, participate in, abets or profacate ragging within or outside of an educational institution, shall, on conviction, be punished with imprisonment for two years and shall also be liable to a fine of rupees ten thousand (10,000/-) or shall be suspended or dismissed from medical college.

Such students will not be admitted in any other educational institution for period of five years from the date of order of such dismissal.

AND
CHARTER**

DEFINITION OF RAGGING

Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student?

WHAT CONSTITUTES RAGGING?

- Any conduct by words spoken or written or an act which has the effect of teasing, threading or handling with rudeness to a fresher or any other student.
- Financial extortion or act of forceful expenditure.
- Physical abuses
- Rowdy/undisciplined activities, which cause or are likely to cause annoyance, hardship, physical/psychological harm or fear or apprehension in any student.
- Forcing a student to do an act, which generates sense of shame, torment or embarrassment affecting his/her physique or psyche?
- Any act which prevents/disturbs/disrupts regular academic activities assignment to a student.
- Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively participating in the discomfiture to fresher or any other student.
- Any act affecting mental health and self-confidence of student with or without any intent to derive a sadistic pleasure showing off power, authority or superiority.

OBJECTIVES

- To Curb the Menace of Ragging in Parul Institute Of Medical Sciences And Research.
- Anti-Ragging Policy-Ragging is strictly banned in the premises of Parul Institute Of Medical Sciences And Research. If anybody found indulging in such activities, strict action

will be taken irrespective of the extent.

- To prevent ragging in the College and also take proper action against those whose are indulging into it.
- To root out ragging in all its forms from the institution by prohibiting it by law and preventing its occurrence by following the provisions of the Regulations of Supreme Court and UGC.
- Spell out suitable punishments to those found guilty.

CONSTITUTION OF ANTI-RAGGING COMMITTEE

1. An anti-ragging committee will be constituted by the head of the institute comprising:
 - a) Chairman
 - b) Co-chairman
 - c) Members (Minimum 4 members) including the wardens of girls and boys hostel.
2. The committee will monitor carefully any ragging incidences in the college premises, canteen, college buses, mess area and hostels through frequent raids.
3. The committee will constitute two squads – one for boy's hostel containing male faculties (Minimum 4 members) and another for girls hostel containing female faculties (Minimum 4 members).
4. The committee will meet & conduct minimum of two meetings biannually.
5. The committee shall re-constitute every three years.

Functions of the Anti-Ragging Committee

1. To monitor an undertaking in the prescribed format from the candidate concerned on anti- ragging at the time of admission.
2. To address the students and parents by the head of the institutions on anti-ragging committee.
3. To arrange to send letters to parents, guardians of the students at the end of the academic year for creation of awareness.



4. To form monitoring cells (Anti-ragging squad's faculties for surprise raids).
5. To suggest measures to tighten the security.

ROLE AND RESPONSIBILITIES OF MEMBERS AS MENTIONED ABOVE

1. The faculty members can take the help of the member students as and when required and can also involve them in different activities relating to Anti-Ragging Committee.
2. To keep an alert eye to avoid any of ragging incidence.
3. Walk around the campus to ensure that there is no such activity taking place.
4. Keep reminding students about the severe actions which could be taken against them if they are found involved or indulged in ragging.
5. Make students aware of their respective Institution about the rules and regulations of Anti-Ragging.
6. Informing students about the affidavit and encourage students to fill and submit it in time.
7. Taking ownership in making the environment of the campus absolutely free from Ragging.
8. Actively participation in monthly meeting of Anti-Ragging Committee or as per the scheduled informed to them from time to time.
9. Identify and keep in close observation of the sensitive places of the Institute where such incidents can take place.
10. For each ragging incident, the member person is supposed to prepare and submit a complete report including their remarks about the incident for further action to the Head of Anti-Ragging Committee.
11. If any such incident is reported to member or member himself/herself comes across such incidents, he/she has to immediately try to get connected telephonically/face to face to the group of students found/reported to indulge in ragging.
12. The member person will immediately investigate about such incident and will take in written



from the doer and the culprit.

13. The member person will also try to collect the information Oral and Written from the witnesses and will put remarks of the witness in the report.
14. Simultaneously, the member person will immediately bring to the notice of Head of Anti-Ragging Committee about such happening as first information and later on will submit an exhaustive report to the Heads for further process and action.
15. Since the gravity of the incident will be decided by the report which will get reflected into the decision of the degree of punishment for the defaulter, it is expected from the each member person that they make/develop the report with utmost sincerity and care.
16. Each such report submitted to the Head of Anti-Ragging Committee will be further investigated by their own resources in order to reach to a right judgment & appropriate decision.
17. The member faculty of each stream of Anti-Ragging Committee will be in close touch with the heads regarding the report they have submitted to the Head. His/her responsibility will not be over just by submitting the report; rather they may also be expected to be a part of decision. Thus, they are supposed to be in touch with the Head till the final verdict upon the case submitted has come out.
18. Each nominated member of the committee is expected to abide by the SOP.

PROTOCOL TO BE FOLLOWED IN CASE OF INCIDENCE OF RAGGING

1. A Formal complaint will be filed with the Anti-ragging committee/Chairman/ member/ members of anti-ragging squads.
2. Authenticity of the case will be examined by the members deputed by the chairman.
3. Initiation of the enquiry process by the by the members deputed by the chairman.
4. After a formal enquiry, the report will be forwarded to the Head of the Institution.
5. Appropriate penalty actions will be recommended to the Head of the Institution as per law.



PENALTIES

The following are the penalties that may be imposed on a student.

Minor Penalties

1. Oral/Written Warning.
2. Fine.
3. Suspension from the class for a week.

Major Penalties

1. Fine.
2. Suspending from class for one month/semester.
3. Prevention from appearing University Exams.
4. Prevention from T & P facilities.
5. Suspension from Hostel.
6. Rustication from college.

ADMINISTRATIVE ACTION IN THE EVENT OF RAGGING

The Institution shall punish a student found guilty of ragging after following the procedure and in the manner prescribed herein as under:

- a) The Anti-Ragging Committee of the Institution shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging established in the recommendations of the Anti-Ragging Squad.
- b) The Anti-Ragging Committee may, depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, award, to those found guilty, one or more of the following punishments, namely:-
 - i. Suspension from attending classes and academic privileges.
 - ii. Withholding/ withdrawing scholarship/ fellowship and other benefits.

- iii. Debarring from appearing in any test/ examination or other evaluation process.
- iv. Withholding results.
- v. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- vi. Suspension/ expulsion from the hostel.
- vii. Cancellation of admission.
- viii. Rustication from the institution for period ranging from one to four semesters.
- ix. Expulsion from the institution and consequent debarring from admission to any other institution for a specified period. Provided that where the persons committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.

- c) An appeal against the order of punishment by the Anti-Ragging Committee shall lie,
- i. In case of an order of an institution, affiliated to or constituent part, of a University, to the Vice-Chancellor of the University;
 - ii. In case of an order of a University, to its Chancellor;
 - iii. In case of an institution of national importance created by an Act of Parliament, to the Chairman or Chancellor of the institution, as the case may be.

ACTION TO BE TAKEN BY THE HEAD OF THE INSTITUTION

On receipt of the recommendations of the Anti-Ragging Squad or on receipt of any information concerning any reported incident of ragging, the Head of institution shall immediately determine if a case under the penal laws is made out and if so, either on his own or through a member of the Anti-Ragging Committee authorized by him in this behalf, proceed to file a First Information Report (FIR), within twenty four hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following, namely;

- i. Abetment to ragging;
- ii. Criminal conspiracy to ragging;



- iii. Unlawful assembly and rioting while ragging;
- iv. Public nuisance created during ragging;
- v. Violation of decency and morals through ragging;
- vi. Injury to body, causing hurt or grievous hurt;
- vii. Wrongful restraint;
- viii. Wrongful confinement;
- ix. Use of criminal force;
- x. Assault as well sexual or unnatural offences;
offences
- xi. Extortion;
- xii. Criminal trespass;
- xiii. Offences against property;
- xiv. Criminal intimidation;
- xv. Attempts to commit any or all of the above mentioned offences against
the victims;
- xvi. Threat to commit any or all of the above mentioned offences against the
victims;
- xvii. Physical or psychological humiliation;
- xviii. All other offences following from the definition of "Ragging".
