Conditions of Registration

1. The registration is valid from 02-May-2021 to 01-May-2026, unless suspended or cancelled by the Central Licencing Authority.
2. This certificate is issued to you on the basis of declaration/submission made by you.
3. Composition of the said Ethics Committee is as per the Annexure.
4. No clinical trial or bioavailability or bioequivalence protocol and related documents shall be reviewed by an Ethics Committee in meeting unless at least five of its members as detailed below are present in the meeting, namely:-
  - (i) medical scientist (preferably a pharmacologist);
  - (ii) clinician;
  - (iii) legal expert;
  - (iv) social scientist or representative of non-governmental voluntary agency or philosopher or ethicist or theologian or a similar person;
  - (v) lay person.

5. The Ethics Committee shall have a minimum of seven and maximum of fifteen members from medical, non-medical, scientific and non-scientific areas with at least,
- (i) one lay person;
  - (ii) one woman member;
  - (iii) one legal expert;
  - (iv) one independent member from any other related field such as social scientist or representative of non-governmental voluntary agency or philosopher or ethicist or theologian.
6. One member of the Ethics Committee who is not affiliated with the institute or organization shall be the Chairperson, and shall be appointed by such institute or organization and one member who is affiliated with the institute or organization shall be appointed as Member Secretary of the Ethics Committee by such Institute or organization.
7. The Ethics Committee shall consist of at least fifty percent of its members who are not affiliated with the institute or organization in which such committee is constituted.
8. The committee shall include at least one member whose primary area of interest or specialisation is non-scientific and at least one member who is independent of the institution.
9. The Ethics committee can have as its members, individuals from other Institutions or Communities, if required.
10. Members should be conversant with the provisions of New Drug and Clinical Trials Rules, 2019, Good Clinical Practice Guidelines for clinical trials in India and other regulatory requirements to safeguard the rights, safety and well-being of the trial subjects.
11. The members representing medical scientists and clinicians shall possess at least post graduate qualification in their respective area of specialization, adequate experience in the respective fields and requisite knowledge and clarity about their role and responsibility as committee members.
12. As far as possible, based on the requirement of research area such as HIV, Genetic disorder, etc., specific patient group may also be represented in the Ethics Committee.
13. The Ethics Committee may associate such experts who are not its members, in its deliberations but such experts shall not have voting rights, if any
14. No member of an Ethics Committee, having a conflict of interest, shall be involved in the oversight of the Clinical trial or bioavailability or bioequivalence study protocol being reviewed by it and all members shall sign a declaration to the effect that there is no conflict of interest.
15. While considering an application which involves a conflict of interest of any member of the Ethics Committee, such member may voluntarily withdraw from the Ethics Committee review meeting, by expressing the same in writing, to the Chairperson. The details in respect of the conflict of interest of the member shall be duly recorded in the minutes of the meetings of the Ethics Committee.
16. Any change in the membership or the constitution of the registered Ethics Committee shall be intimated in writing to the Central Licencing Authority within thirty working days.
17. The Ethics Committee shall review and accord approval to a Clinical trial, Bioavailability and Bioequivalence study protocol and other related documents, as the case may be, in the format specified in clause (B) of Table 1 of the Third Schedule of New Drugs and Clinical Trials Rules, 2019 and oversee the conduct of clinical trial to safeguard the rights, safety and wellbeing of trial subjects in accordance with these rules, Good Clinical Practices Guidelines and other applicable regulations.
18. Where a clinical trial site does not have its own Ethics Committee, clinical trial at that site may be initiated after obtaining approval of the protocol from the Ethics Committee of another trial site; or an independent Ethics Committee for clinical trial constituted in accordance with the provisions of rule 7: provided that the approving Ethics Committee for clinical trial shall in such case be responsible for the study at the trial site or the centre, as the case may be: provided further that the approving Ethics Committee and the clinical trial site or the bioavailability and bioequivalence centre, as the case may be, shall be located within the same city or within a radius of 50 kms of the clinical trial site.
19. Where a Bioavailability or Bioequivalence study centre does not have its own Ethics Committee, bioavailability or bioequivalence study at that site may be initiated after obtaining approval of the



from the Ethics Committee registered under rule 8: Provided that the approving Ethics Committee shall in such case be responsible for the study at the centre: Provided further that both the approving Ethics Committee and the centre, shall be located within the same city or within a radius of 50 kms of the bioavailability or bioequivalence study centre.

20. Ethics committee shall indicate the reasons that weighed with it while rejecting or asking for a change or notification in the protocol in writing and a copy of such reasons shall also be made available to the Central Licencing Authority.

21. Ethics committee shall make, at appropriate intervals, an on-going review of the trials for which they have reviewed the protocol. Such a review may be based on the periodic study progress reports furnished by the investigators or monitoring and internal audit reports furnished by the sponsor or by visiting the study sites.

22. Where any serious adverse event occurs to a trial subject or to study subject during clinical trial or bioavailability or bioequivalence study, the Ethics Committee shall analyse the relevant documents pertaining to such event and forward its report to the Central Licencing Authority and comply with the provisions of Chapter VI, New Drugs and Clinical Trials Rules, 2019.

23. The Ethics committee shall undertake proper causality assessment of SAE's with the help of subject experts wherever required, for deciding relatedness and quantum of compensation, as per condition no (22) mentioned above.

24. Where at any stage of a clinical trial, it comes to a conclusion that the trial is likely to compromise the right, safety or wellbeing of the trial subject, the Ethics committee may order discontinuation or suspension of the clinical trial and the same shall be intimated to the head of the institution conducting clinical trial and the Central Licencing Authority.

25. Ethics committee shall comply with the requirements or conditions in addition to the requirements specified under the Drugs & Cosmetics Act, 1940 and New Drugs and Clinical Trials Rules, 2019, as may be specified by the Central Licencing Authority with the approval of the Central Government, to safeguard the rights of clinical trial subject or bioavailability or bioequivalence study subject.

26. Ethics Committee shall review and approve the suitability of the investigator and trial site for the proposed trial.

27. The Ethics Committee shall maintain data, record, registers and other documents related to the functioning and review of clinical trial or bioavailability study or bioequivalence study, as the case may be, for a period of five years after completion of such clinical trial.

28. Funding mechanism for the Ethics Committee to support their operations should be designed and approved to ensure that the committee and their members have no financial incentive to approve or reject particular study.

29. SOP's for funding of the Ethics committee in order to support their operations must be maintained. The records of income & expenditure of Ethics Committee shall be maintained for review and inspection.

30. The Chairman of Ethics Committee shall enter into MOU with head of institution, that necessary support and facilities and independence will be provided to Ethics Committee and their records will be maintained.

31. The Ethics Committee shall allow any officer authorized by the Central Licencing Authority to enter, with or without prior notice, to inspect the premises, any record, or any documents related to clinical trial, furnish information to any query raised by such authorized person, in relation to the conduct of clinical trial and to verify compliance with the requirements of these rules, Good Clinical Practices Guidelines and other applicable regulations for safeguarding the rights, safety and well-being of trial subjects.

32. Where Central Licencing Authority is of the opinion that Ethics Committee fails to comply with any provision of the Drugs and Cosmetics Act, 1940 and New Drugs & Clinical Trials Rules, 2019, it may issue show cause notice to such Ethics Committee specifying therein such non-compliances and the period within which reply shall be furnished by such Ethics Committee. After consideration of the facts and reply given by the Ethics Committee, the Central Licencing Authority may take one or more actions specified under provision of Rule 14, Chapter III of New Drugs and Clinical Trials Rules, 2019.





In partial modification of the notification cited at ref.(i), the following changes are made

**1. In Point Number 8.5- incentives offered to the authors of publications are revised as follows:**

**2. In 8.5, under Note, after the sentence- " no incentive shall be admissible for writing " Review of Book" in any journal/ magazine- the following sentence shall be added:**

"For incentives claimed by the faculty members for Review Articles of PG students, the amount will be reduced by 50% of the entitlement.

**3. In 8.6, under " Promoting publication of books/ book chapters", after v), the following shall be added:**

Publication of Book/Book chapter by LAP-Lambart or publisher of same status (National/International) shall be treated as follows:

- Book with pages more than 200 will be treated as a Book published by an Indian publisher (Category B).



- Book with pages less than 200 will be treated as a Book chapter published by an Indian publisher (Category B).
- Book with pages less than 100 will be treated as a review article equivalent to a journal without impact factor (UGC-CARE/Web of Science).

4. **In 8.6, in the NOTE section, the following shall be added as (4)**

The above Note will not be applicable to Book chapters published by International publishers (Category A).

5. **In 8.7., after (viii), the following may please be added in (ix)**

ix) Online Paper presentation in National/International conference:

An amount equal to 75 % of the Registration fee but not exceeding Rs. 10,000/- would be payable to the applicant with the submission of documentary evidence for presentation of the paper.

6. **In 8.7, in the Note Section, the following shall be added after (1)**

- For Papers (oral/poster) having the names of the faculty members but presented by students/scholars in National/International conferences/symposia, there will be NO incentives given to the faculty members.
- Paper presented in International conference should be of high standard worth publication in reputed International journals. For paper presentation (physical/OFFLINE mode) in International conference, 50 % of the claimed amount will be released on demand after attending the conference and the rest 50 % would be released after providing a proof of publication of the work (presented in the conference) in peer reviewed UGC-CARE listed journal.

7. **After 8.10, the following shall be added in 8.11 and in 8.12**

**8.11** Membership of Professional bodies: An amount equal to 50 % of the Membership Fee to a maximum of Rs. 5000/- will be payable to the applicant. Membership of ONLY ONE professional body per year will be admissible by an applicant.

**8.12 Honoring the Award winner:** A token amount of honorarium shall be paid to the award winner as follows:

Dr. Datta Madamwar conveyed his inability to attend the meeting as he was travelling that day, and no intimation was received from Dr. Rajesh Dubey who did not attend the meeting.

A. The Member Secretary welcomed the Chairperson and the members of the committee for the inaugural meeting of Research Advisory Committee, Parul University, and requested the Chairperson to take the chair and start the proceedings. The Chairperson in his inaugural address emphasized the following points:

1. Publications should be done in quality journals especially in Q1 and Q2 journals.
2. We should aim that all Parul University teaching faculty should be Ph.D. qualified by the year 2026.
3. Non-Ph.D. teaching staff should register themselves for Ph.D. in universities other than Parul University, in case of absence of qualified supervisors in particular fields in PU.



4. Quantum and number of Extramural research grants should be increased.
5. Patent filing in the University should be facilitated and training should be imparted to the staff/students for patent awareness.
6. Year-wise list of registered Ph.D. scholars should be prepared.
7. Research awards should be instituted for recognition of good researchers.
8. Year-wise list of Ph.D. degree awardees should be prepared and hosted on the website.
9. Ph.D. thesis should be uploaded in Shodhganga.
10. Plagiarism should be checked using software like Turnitin/iThinkIt.
11. Research profile of all teachers should be available on PU website.
12. List of research supervisors with their profiles should be made available on the University website.
13. Research should be incentivized.
14. PU should be made a research hub in due course of time.
15. There is a need for the preparation of approved journals' list for those Faculties where only a limited number of research journals are available.
16. Research facilities need to be strengthened in all faculties.
17. Research committees should be constituted at Institute/Faculty level.
18. Research culture should be inculcated among the undergraduate students also apart from the PG students and the teaching staff.
19. Interdisciplinary and multidisciplinary research should be encouraged.
20. Research clubs should be formed at different levels.
21. Research facilities available at Department/Institute level with a list of equipment/instruments costing more than 10 Lakhs should be prepared and shared on the university website.
22. List of Superspeciality labs and Labs for Skill development in individual Faculties should be shared.
23. Current research standing of individual Departments/Faculties in terms of publications and expertise available should be shared.
24. Each Institute/Faculty should disclose Innovative and the best practices adopted for promoting research in the institute/Faculty.
25. Year-wise research plans at Faculty level should be chalked out and implemented.

B. Dr. M. R. Yadav apprised the Chairperson and the members that a number of the above mentioned points are already in place in the University, and the others could be taken up and complied in phased manner. Dr. Yadav also apprised the committee of the activities undertaken at CR4D as listed below:

#### **I. R & D ACTIVITIES**

- i) In-house R & D activities
  - ❖ Creation of Lab facilities



- Research Labs made functional under Biotechnology discipline
  - Animal Tissue Culture Lab
  - Mycology lab
  - Microbiology Lab
  - Cell biology Lab
- Research Labs under development
  - Nanotechnology Lab
  - Pharmaceutical Technology Lab
  - Environment Science Lab
- ❖ Creation of Sophisticated Instrumental Lab with instruments like, HPTLC, GC, FT-IR, UV-Visible spectrophotometer, Digital weighing balance and pH meter already procured, installed and functional.
- ii) Augmenting R & D activities in the University
  - ❖ Granting IMR projects to the faculties upto Rs. 2 Lacs.
  - ❖ Incentivizing the research by offering incentives for research/review paper publication, book/book chapter writing, patent filing/design/copyright registration filing.
  - ❖ Offering seed money to faculty for attending conference/seminar/symposia/workshops/FDP/SDP etc.
  - ❖ Offering seed money to faculty for becoming members of professional bodies.
  - ❖ Organizing Research Excellence Awards
  - ❖ Screening of research proposals before being sent to the external funding agencies by the staff members.

## II. PROMOTING IPR RELATED ACTIVITIES

- i) Safeguarding of IPR
    - ❖ Facilitating IP protection by filing Patent/Design/Copyright registration applications.
    - ❖ Incentivizing IPR protection by bearing the cost involved in the filing process and thereafter.
  - ii) Organizing awareness programs in institutes for sensitizing the faculty and the students about various types of intellectual properties, and the ways and means of safeguarding them.
  - iii) Organizing workshops for prior art search for preparing search report.
- C. During the discussion, suggestions were given by the committee members for improving the research profile of the University as given below:
1. Participation of faculty members in international conferences held abroad should be encouraged by fully funding the expenses, as foreign level participation not only enhances the research exposure of the attending faculty member, but also brings the




name of PU in lime light at the international level. In such cases, a part of the expenses could be disbursed to the applicant after he/she has attended the conference and the remaining amount can be reimbursed after a specified period during which the applicant should publish the presented research work in a high ranked SCI/SCOPUS indexed Q1/Q2 journal.

2. During the recruitment of faculty, well qualified research-oriented teachers only should be recruited, and quality research students to be admitted in PG and Ph.D. courses.
3. Research funding should be given to a group of students at UG level under the mentorship of a teacher on the pattern of IMR funding.
4. The process of applying for extra-mural funding to the external agencies should be centralized and channelized through CR4D. This can be made possible by putting a condition of mandatory signature from CR4D before the signature of the Registrar on the application form, whether it is ONLINE or OFFLINE application.
5. Research profile of all teachers should be shared through university website.
6. Abstracts of PG and Ph.D. theses should be shared through website.
7. Research clubs should be created in institutes and club meeting should be organized every fortnight or so.
8. Inter-faculty research clubs should also be formed with 2/3 active researchers from each faculty.
9. Some top-notch researchers from industry should be invited in the University for collaborative research projects.
10. Weekly/fortnightly research-related seminars should be arranged at Department level for larger faculties and at faculty level in smaller faculties.
11. MoUs signed at University level for R & D activities should be made available to all to utilize the research facilities of other institutions under MoU.
12. Procurement of quality chemicals/consumables should be catalyzed and put on fast track.

The inaugural meeting of the council was convened on 18<sup>th</sup> July 2023 at 2:30 P.M. in the Committee Room, Research and Development cell. The Registrar, Prof. Manish Pandya and Dean, Doctoral studies and Research, Dr. Purvi Shah were invited as special invitees to attend the meeting.



All the members attended the meeting in person except for Dr. Niraj Kumar Singh who joined the meeting through ONLINE mode. Dr. Karthik Vishwanathan, Director, IQAC, Dr. Sanjay Chaudhary and the special invitee Prof. Manish Pandya could not attend the meeting.

The meeting was chaired by the provost Dr. Amit Ganatra. After introduction of all the members, Dr. M. R. Yadav welcomed the members and gave a brief introduction about the inception of R & D Center at Parul University somewhere in 2018. The Center was formally named as '**Center of Research for Development**' in Aug 2019. The center is popularly known as CR4D in the University circles. After the UGC notification of its letter (F. No. 1-5/2021(NEP/DESK-PARL dated 14<sup>th</sup> March 2022) and UGC "Guidelines for Establishment of Research & Development Cell in Higher Education Institutions, March 2022, it was felt that we should follow the UGC guidelines and adopt the same nomenclature for the Center as given by the UGC, New Delhi. Hence, the Center was renamed as **Research & Development Cell (RDC)**.

The meeting was convened to discuss the ongoing activities and future plans of the Research & Development Cell (RDC) at Parul University. The following topics were discussed:

- Updates on the progress of the ongoing research and development projects and initiatives at the university.
- Role and responsibilities of the RDC in organizing and facilitating research and development-related events.
- Future plans and activities of RDC for the upcoming academic year.
- Identification of actionable objectives and key performance indicators for monitoring the progress of research and development activities at the university.
- Suggestions for further improvement of the RDC infrastructure and to optimize the R&D process.

Dr. Yadav briefed the members about the activities/functions undertaken by the Cell. In nutshell, the following information was provided by Dr. Yadav to the members:

#### **I. RESEARCH PROMOTIONAL ACTIVITIES**

- Conducting of sensitization programs for UG, PG and Ph.D. students, and Faculty members for undertaking R & D activities, writing of research proposals and writing of research/review articles in journals of repute.
- Performing preliminary screening of research proposals applied by the faculty members for extra-mural funding.
- Granting of intra-mural research funding to the faculty members after due scrutiny, mid-term monitoring of the progress of the sanctioned projects, and follow up of the completion of the projects.
- Promoting research publications by the faculty members by offering suitable incentives as per the laid down norms in R & D Policy of the University.
- Framing and revising of policies like R & D Policy and IPR Policy of the University from time to time.
- There is a GUJCOST recognized IPR Cell under RDC, which is engaged in spreading of IPR awareness among the students and faculty of the University by organizing expert talks/seminars on IPR, and on the ways and means of protection of intellectual property created in the University.
- The IPR cell extends full support and finance to the teachers and students of the University for filing of patent/design applications to the Indian Patent Office.



## **II. R & D ACTIVITIES AT RDC**

- DRC has already developed ten fully functional labs for research work in different fields of biological and chemical sciences.
- Many sophisticated instruments have already been procured for research purposes and many more are in the process of procurement.
- Pharm. Tech. Lab and Central Sophisticated Instrument Lab are currently in the process of getting established.

## **III. RESEARCH PERSONNEL**

- Currently ten research scientists are working in various labs in RDC, like Biotechnology lab, Mycology lab, Microbiology lab, Structural biology and Biophysics lab, Cell biology lab, Chemistry lab, Material science lab, Nanotechnology lab and Bioinformatics and Molecular modeling lab.
- The process of employing 3-4 research personnel are in progress.

## **IV. RESEARCH SCHOLARS**

- Eight full time research scholars are currently working in different projects in RDC. Apart from the Ph. D. students, PG students are also working and getting training in these labs.

After a brief introduction of the RDC activities by the Director, individual members of the Council expressed their views to promote R & D activities in the University as follows:

- Dr. Amit Ganatra, Chairperson of the Council expressed his satisfaction at the progress made by RDC in a short span of time. He emphasized on the publication of research articles by the University scholars/teachers only in Q1 and Q2 journals indexed by SCI, SCOPUS and Web of Science.
- Dr. Datta Madamwar put an emphasis on applying for research projects to various funding agencies. He informed the members that a majority of government funding agencies has stopped/reduced funding for major equipment, but we must strive to apply for funding for the recurring expenses, which is also quite high these days, especially in the field of biological sciences.
- Dr. Murthy suggested taking up research projects which have social relevance. He deliberated at length about the joint Industry-academia research project sanctioned by Royal Society of Engineers, U.K. to the Faculty of Engineering and Technology, PU.
- Dr. Prasanna talked about his involvement and help extended to the teachers and students of Faculty of Ayurved in carrying out their research projects. He also mentioned about the GSBTM project currently running under his supervision in the Faculty of Ayurved.
- Dr. Purvi gave the status of the number of Ph.D. students (full time as well as part-time) registered currently in the University and the number of registered Ph.D. supervisors. She also mentioned that the University is aiming to have 100 % Ph.D. holding teaching staff by the year 2027.
- Dr. Anand Joshi mentioned about various research projects running in Faculty of Engineering & Technology. He also informed the members that the University is in the process of obtaining an "Advanced Research Center in Nanotechnology" by Government of Gujarat.
- Dr. Gireesh Babu mentioned that the Faculty of Applied Sciences has signed an MoU with GBRC, Govt. of Gujarat for research collaboration.
- Dr. Abhay was of the view that academia should collaborate with the industry for fruitful and productive research, especially in the Pharma field. The academic staff should be



exposed to the industries to have a feel of the industry environment.

- Dr. Chhabria was of the view that in research publications we should not compromise on the quality. We should elevate our minimum standards above those set by the regulatory bodies and we should not run after the number game especially in publications.
- Dr. Niraj Kumar extended his full co-operation and help to the PU researchers in offering the research facilities of GBRC. He informed that there is a provision of offering research facilities at 50 % of the actual cost to the research students, and on cost to cost basis to the teachers of the Universities. He also mentioned about various sophisticated facilities available in the field of biotechnology in GBRC.
- Since the basic idea behind establishing an RDC is to encourage multidisciplinary research work in the institutions of higher learning, Dr. Yadav requested PU members of the Council to have more frequent visits to RDC along with their research staff so that exchange of ideas can take place for more effective multi-disciplinary research work. He also requested the Chairperson, RAC to extend help in establishing research labs of other disciplines in RDC, so that the dream of real multi-disciplinary, interdisciplinary and trans-disciplinary research could be realized.

After extensive discussion, participants unanimously agreed to the following:

- The RDC will strive to create more awareness about research opportunities available to the students at Parul University.
- The RDC will collaborate with industry partners to create research and development initiatives that will provide the students with an opportunity to gain real world experience.
- The RDC will continuously monitor the progress of research and development projects and evaluate performance against set objectives for each project.
- The RDC will review the current performance indicators and identify areas for further improvement.

**Some future plans for development are mentioned as below:**

- Development of Central Sophisticated Instrument Lab.
- Procurement of some important instruments of common use to the University researchers.
- Addition of research laboratories of some disciplines depending on the expertise of the research staff.
- Employing scientists of disciplines like Ayurved, phytochemistry/organic chemistry/Pharm. Chemistry for performing multidisciplinary research work.

Dr. Yadav, convener of the Council, thanked the members profusely for sparing their time and offering valuable inputs to promote research in Parul University.

The meeting ended with a vote of thanks to the chair.



2. It is recommended to purchase the subscription of J-Gate, Scopus and Web of Science Database so that faculty members, researchers, Ph.D. Student and PG Scholars can get free access and they can actively check h-index, citations of not only their individual publications but also publications from other researchers from Parul University.
3. It is suggested to inform Institutional Research coordinators about Scopus and Web of Science-discontinued list of Journals from CR4D time to time so that information will be disseminated and faculty members will stop publishing their manuscripts in such journals, which are discontinued in Scopus and Web of Science.

4. It is recommended to support article-processing charges (APC) to the faculty members for publishing articles in SCI/Scopus/WoS (ESCI not included) listed journals, which would be reimbursed (with a maximum limit of Rs. 25000/- per article) subject to submission of relevant documents.
5. Quality publications have started coming out in the last 4 years after establishment of 'Publication Monitoring Committee', which is an indicator of improvement in publication metrics and standard/quality of publications from faculty members, researchers and Ph.D. students from Parul University. In year 2021 and 2022, total 336 and 442 quality manuscripts get published in peer reviewed journals indexed in SCI, Scopus, Web of Science, PubMed and others.
