Sir,

With reference to the subject cited above and comments received from the college Medical Assessment and Rating Board for Homoeopathy hereby issue a revised permission in supersession to the previous communication made with regard to the permission matter for admission at Ahmedabad Homoeopathic Medical College, Ahmedabad.

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020. As per section 59 (2) of NCH Act, 2020, following has been stated:

“Notwithstanding the repeal of the Homoeopathy Central Council Act 1973, the educational and medical standards, requirements and other provisions of the Homoeopathy Central Council Act, 1973 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder: Provided that anything done or any action taken as regards the educational and medical standards and requirements under the enactment under repeal and the rules and regulations made thereunder shall be deemed to have been done or taken under the corresponding provision of this Act and shall continue in force accordingly unless and until superseded by anything or by any action taken under this Act”.

As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 proforma were examined by the Medical Assessment and Rating Board.

2. On careful consideration of the report, the Medical Assessment and Rating Board has arrived at the following conclusion:-

That the applicant has set up a Homoeopathic Medical College with the component of staff, infrastructure, equipment and instruments and other facilities where as the College has to take certain time bound steps to implement Minimum Standard Requirements of the Homoeopathy College and attached Hospital as prescribed by the National Commission for Homoeopathy for conducting BHMS course. The deficiencies observed are as follows:



**1. Hospital Staff:**

- i. Name of Obstetricians/ Gynecologist (Dr. Harshabdhai E. Patel) not found in acquaintance roll.

**2. Teaching Faculty: UG Full time:** College has 34 Full time faculties against the requirement of 28 Full time faculties.

**PG: Full time Faculty: 03** PG Faculties are available. (02 Prof, 01 Reader & 01 Lecturer) Required teachers are not available in Organon and Repertory

**Guest Faculties: - 05** Guest Faculties (02 Professor & 03 Reader) available against the required number of 12.

**Part Time Teachers:** 02 eligible as names of 07 teachers of (2 Full time faculties and 5 Guest faculties) are mentioned as Part time teachers. Hence only 2 are available against the requirement of 9 part time teachers from teaching consultants/ Teachers of Modern Medicine are same.

**3. Discrepancies in engagement of teachers**

**For UG Courses**

A. No previous experience/ details of Guest Faculty provided

B. **Organon:** Dr. Vinod P. Vaidhya, DHMS, Prof. ORG: Joined as Lect. on 01.12.2017 at age of 40 years 01 months (DOB 17.10.1977). No other experience/ details provided

C. **FMT:** Dr. Jagruti V. Patel, MD (Hom), Lect. FMT: Discrepancies in joining date as Joined as Lect. on 01.03.2013 but PG degree obtained in 2015. No other experience/ details provided.

D. **CMD:** Dr. Nitin M. Joshi, MD (Hom), Lect. CMD: Joined as Lect. on 01.12.2017 at age of 53 years 10 months (DOB 19.06.1967). No other experience/ details provided

**For PG Courses**

**A. ORGANON OF MEDICINE:**

1. Dr. Dhiren A. Kubavat, MD (Hom), Lect. ORG: Joined as Lecturer on 01.01.2018 at age of 43 years 02 months (DOB 21.10.1974). No other experience/ details provided

3. After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC(MSR) Regulations, 2013, permission of the Medical Assessment and Rating Board is issued to Ahmadabad Homoeopathic Medical College, At & PO. Ghuma- Bopal Road, Ghuma, Ahmedabad.-380058 GUJARAT **for continuing admissions for BHMS with 100 seats and 18 seats 03 PG subjects namely Homeopathic Materia Medica and Repertory & Organon of Medicine with 06 seats for the academic session 2021-22. The College Principal is directed to fulfill the deficiencies mentioned above, within three months and an affidavit in this regard may be submitted to the Medical Assessment Board, National Commission for Homoeopathy within a period of one week.**

4. All admissions in Under Graduate/Post Graduate course shall be through NEET/AIAPGET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that




State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted thereunder.

5. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board as per rules.

6. The college has to comply with the full requirements of Minimum Standard Requirements Regulations, 2013 for conducting the course. All deficiencies observed and mentioned above which affects the performance of the academic Institution, through which College fails to fulfill the statutory requirements, has to be rectified within three months time from the date of issue of this permission letter and the compliance report shall be submitted by the college to Medical Assessment and Rating Board accordingly. Subsequently, the Board shall verify the compliance well in time and may conduct Online/Physical inspection for verification of compliance as per the HCC (MSR) Regulation, 2013 and will consider admissions for the academic year 2021-22.
